

<b>FACTS</b>		<b>WHAT DOES C-III CAPITAL PARTNERS LLC DO WITH YOUR PERSONAL INFORMATION?</b>
<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
<b>What?</b>	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> <li>▪ Social Security number</li> <li>▪ Account balances, account transactions and transaction history</li> <li>▪ Wire transfer instructions</li> </ul>	
<b>How?</b>	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons C-III Capital Partners LLC chooses to share; and whether you can limit this sharing.

<b>Who is providing this notice?</b>	C-III Capital Partners LLC and its subsidiaries and affiliates, including its investment adviser and broker dealer subsidiaries and affiliates (collectively, "C-III")
What We Do	
<b>How does C-III protect my personal information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
<b>How does C-III collect my personal information?</b>	We collect your personal information, for example, when you <ul style="list-style-type: none"> <li>▪ Open your account</li> <li>▪ Seek advice about your investments</li> <li>▪ Provide account information</li> <li>▪ Enter into an investment advisory contract</li> <li>▪ Make a wire transfer</li> </ul>
<b>Why can't I limit all sharing?</b>	Federal law gives you the right to limit only: <ul style="list-style-type: none"> <li>▪ sharing with affiliates' everyday business purposes---information about your creditworthiness;</li> <li>▪ affiliates from using your information to market to you; and</li> <li>▪ sharing with nonaffiliates to market to you.</li> </ul> State laws and individual companies may give you additional rights to limit sharing.
<b>What happens when I limit sharing for an account I hold jointly with someone else?</b>	Your choices will apply to everyone on your account -- unless you tell us otherwise.
Definitions	
<b>Affiliates</b>	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>▪ Our affiliates include companies with a C-III or Resource name; financial companies (including <i>Anubis Securities LLC, C-III Investment Management LLC, Resource Real Estate, LLC, Resource Alternative Advisor, LLC, Resource Financial Institutions Group, LLC, Ischus Capital Management, LLC, Exantas Capital Manager, Inc. and Resource Securities LLC</i>; nonfinancial companies (including <i>C-III Commercial Mortgage LLC</i>); and others (such as <i>C-III Realty Services LLC (d/b/a NAI Global), New America Network Inc. and The Planning &amp; Zoning Resource Company LLC</i>).</li> </ul>
<b>Nonaffiliates</b>	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>▪ Nonaffiliates we share with can include various service providers to assist in the administration of the investment funds and accounts advised by C-III and its subsidiaries and affiliates.</li> </ul>
<b>Joint marketing</b>	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> <li>▪ C-III does not jointly market.</li> </ul>
